#### Notice on Change of Representative Director (Resignation) and Change of President

Today, our Company accepted the resignation of the President and Representative Director Kento Hayashi from his position as President and Representative Director of the Company. In order to clarify his management responsibility for the large extraordinary losses recorded in the "Disclosure Update: Losses of Consolidated Subsidiary" and the significant downward revision of the full-year earnings forecast for FY2024/3 as announced in the "Notice on Reversal of Deferred Tax Assets and Revision of Full-Year Consolidated Earnings Forecast" and the fall into the red etc., he offered to resign as Representative Director and President, and we have accepted this offer. The Company also announces that its Board of Directors today passed a resolution regarding the change of representative director (change of President and Representative Director and CEO).

#### 1. Reason for the change

Today, our Company has accepted the request for resignation submitted by the Representative Director from his position as President and Representative Director of the Company as of February 14, 2024. In order to clarify his management responsibility for the large extraordinary losses recorded in the "Disclosure Update: Losses of Consolidated Subsidiary" and the significant downward revision of the full-year earnings forecast for FY2024/3 as announced in the "Notice on Reversal of Deferred Tax Assets and Revision of Full-Year Consolidated Earnings Forecast" and the fall into the red etc., he offered to resign as Representative Director and President, and we have accepted this offer.

Accordingly, the Board of Directors resolved on February 14, 2024, to appoint Shinichi Iwata, Vice President and Representative Director and CFO of the Company, as President and Representative Director, CEO and CFO of the Company, effective the same day.
